Pet Friendly Policy & Procedures

At Divyam from BYLOO, we understand that your pet is just as much a part of the family as other members. We're thrilled to be a pet-friendly homestay and welcome dogs / cats at our property. In order to ensure that all of our visitors have an enjoyable stay, we ask that guests traveling with their four-legged friends sign the policy below upon check-in.

I have read and agree to the following:

- My pet(s) weighs 75 pounds or less.
- I understand that only two pets are allowed during a stay.
- My pet's vaccinations are up-to-date and he or she is free of fleas or ticks.
- My pet is not aggressive and is well-socialized with other animals and guests.
- I agree to clean up after my pet and properly dispose of any waste.
- I understand that my pets are not allowed on the furniture.
- My pet will be with me and under my care at all times as they are not to be left unattended on property.
- I agree to hang a 'Pets are Welcome' door hanger on my door at all times while my pet is inside. I understand that Housekeeping will not enter my room with an unattended pet inside. My pet must be restrained or removed from guest room while villa staff is present working in room. I will assume responsibility for notifying the villa staff if there are special times for servicing my room.
- My pet will be on a leash with a maximum range of six feet or in a carrier at all times when outside of the room.
- I understand that a non-refundable pet charge of INR 1000 per dog per day will be charged or post-departure room cleaning. I further understand that this fee does not include any additional costs which may result from damage or need for excessive cleaning of soiled linens, carpeting or furniture.
- I am aware that an additional charge will apply if excessive cleaning is necessary. I also agree that the condition of the room is based on the sole judgment of management upon my departure.
- As a pet owner, I am liable for any disturbances my pet causes to guests and staff staying at Divyam. On any untoward incident involving disturbance or damage to people or property, I understand that I will be asked to remove my pet immediately.
- I understand that my pet is not permitted at any of villa's cooking and dining areas.
- Villa is not liable for any injury suffered by pet while on premises.
- I accept full responsibility for any liability arising from my pet (pet damage or personal injury to villa, villa staff, guest, third party or property).
- I acknowledge that I have been informed of Divyam villa's pet-friendly policies and procedures. I am aware that I may be responsible for additional fees if damage, excessive noise and/or flea infestation occurs during my stay.
- I understand that I need to carry the bedding and the food bowl for my pet and that pets are not allowed on the guest beds.
- I understand that the villa does not store any pet food and if I require any meals for my pet from the villa kitchen the same will be on a chargeable basis.
